- 1. - 2. Further to clause 1 hereof the member HEREBY ASSIGNS to the Society all accrued cause Of action wherever and whenever in respect of any infringement of the said right in any Such musical works/ sound recording in so far as the same are now vested in the members.
- 3. In furtherance of the rights here in before granted, the Society HEREBY UNDERTAKES to use its and to collect the royalties, fee and other sums arising under licenses granted by the Society or otherwise, and to remit same to the Member promptly subject however to deduction of necessary costs AND the Member HEREBY UNDERTAKES to do all such further acts, deed and execute, accede to all such further document and instruments as may from time to time be necessary to give effect to this agreement.
- 4. The member HEREBY COVENANTS with the society that the member has a good right and full power to assign the rights herein mentioned and that the work herein assigned do not or will not infringe any copyright or other right AND the member FURTHER COVENANTS to indemnify and keep the society indemnified against any loss, injury or damaged (including any legal costs or expenses and any compensation, cost and disbursement paid by the society on the advice of counsel to compromise or settle any claim) occasioned to the society in consequence of breach of any copyright or other right conditions or warranty by the Member.
- 5. All right, duties and obligations arising from this assignment shall be subject be subject to the provisions of the Articles of Association of the society and any other rules or regulations made pursuant thereto.
